Only methods approved by EEFCU may be used to make withdrawals from this account. 2. EEFCU is under no obligation to pay any item that exceeds the fully paid and collected share balance in the account; EEFCU may, however, pay such items and transfer shares to this account in the amount of the resulting overdraft, plus any service charge, from any other regular share account from which any of the undersigned is then eligible to withdraw funds. 3. EEFCU may pay any item on whatever day it is presented for payment, notwithstanding the date (or any limitation on the time of payment) appearing on said item. Except for negligence, EEFCU is not liable for any action it takes regarding the payment or nonpayment of an item. 4. 5. Any objection regarding any item shown on a periodic statement of the account is waived unless made in writing to MEPFCU before the end of 60 days after the statement is mailed. This account is subject to the credit union's right to require advance notice of withdrawal, as provided in its bylaws. 6. 7. This account is also subject to such other terms, conditions and service charges as EEFCU may establish from time to time. 8. If this Agreement is signed by more than one person the persons signing below shall be the joint owners of this account which in that event, shall be subject to the additional terms and conditions: EEFCU is hereby authorized to recognize any of the signatures subscribed on the reverse side hereof in the payment of funds or the transaction of any business of the account. The joint owners of this account hereby agree with each other and EEFCU that all sums now paid in on shares, or heretofore or hereto after paid in on shares by any or all said joint owners to their credit as such joint owners with all accumulations thereon, are and shall be owned by them jointly, with right of survivorship and be subject to the withdrawal or receipt of any item, and payment to any of them or the survivor(s) shall be valid and discharge EEFCU from any liability for such payment. The right or authority of EEFCU under this agreement shall not be changed or terminated by said owners, or any of them except by written notice to EEFCU which shall not affect transactions already made. I authorize the Credit Union to obtain credit reports in connection with the application for any share account. If requested, the credit union will provide the name and address of any credit bureau from which it receives a credit report.
